**Prospective Vendor Expectations**

1. Booth cost is \$40
2. Booths will be 10x10 spaces. If you need a larger space please add in the comments. (There may be an added charge)
3. Setup will start at 10am and must be completed by 11:30am.
4. Electricity will **NOT** be provided.
5. Booths must remain on site for the entire duration of the event to reduce the risk of injury to participants and patrons. (You can start putting inventory away, but cannot move things off site).
6. Tear down will begin at 4pm.
7. Deposit of \$20 is required **within 7 days** of being approved to secure your spot. Remainder of the booth fee is due by **Monday November 15th**.
8. Make sure to list exactly what you are selling. Company brands are limited to one vendor for the event and are on a first come first serve basis.
9. If you sell more than one company brand, you might be told you cannot set up one of the brands in your booth. Please understand that means someone else is already committed to that brand. You will be notified during the approval process if this is the case.
